1 **[PROPOSED] ORDER**

2 Having read and considered Plaintiffs' Notice re: Status of Distribution of Net Settlement  
3 Fund and Request to Reset Deadlines ("Notice"), and finding good cause thereon, the Court hereby  
4 grants the relief requested in the Notice, and orders as follows:

5 1. the third distribution plan set forth in the Nordskog Report (¶¶12-17), attached as  
6 Exhibit 1 to the Notice is approved;

7 2. the Third Distribution Timeline, attached as Exhibit A to the Nordskog Report is  
8 approved;

9 3. the deadline for submission of the Claims Administrator's Final Report is reset from  
10 September 15, 2025 to April 3, 2026, unless a fourth distribution is appropriate, in which case  
11 Plaintiffs will provide the Court with an update by April 3, 2026; and

12 4. the deadline for submission of the Stipulation and Proposed Order and Proposed  
13 Amended Judgment is reset from October 15, 2025, to May 1, 2026, unless a fourth distribution is  
14 appropriate, in which case Plaintiffs will request a new deadline in conjunction with their April 3,  
15 2026 update.

16 5. The Non-Appearence Case Review re Amended Judgment is continued to May 15, 2026.
